1. Values and Ethos

This policy covers the Greenwood Academies Trust's (GAT) approach to how we expect our academies to support children's development and understanding around relationships, health and sex education. The policy is developed in line with the expectations of the DfE Statutory Guidance for RSE (first published in June 2019). The policy has been developed in such a way so that it can be adapted and personalised to become an academy level document. GAT requires each academy to have a policy for RSE in place.

We define 'relationships and sex education' as a curriculum which will help our children grow in confidence and understanding relating to how they as individuals will develop, grow and mature into responsible individuals.

- ✓ We believe relationships and sex education is important for our academies because it will help our children to value positive relationships and to have the confidence and strength of character to identify and lead a healthy lifestyle.
- ✓ We view the partnership of home and academy as vital in providing the context of open discussion, honesty and support.

The intended outcomes of the programmes of study are that pupils will:

- Know and understand, how as individuals our bodies change as we get older.
- Understand they have the right to be safe.
- Understand they have a responsibility to be a responsible, valued member of the academy.
- Develop the skills needed to lead a healthy lifestyle.
- Develop the attributes of positive relationships.

2. Aims

The aims of relationships and sex education (RSE) are to:

- Provide a framework in which sensitive discussions can take place
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- Help pupils develop feelings of self-respect, confidence and empathy
- Create a positive culture around issues of sexuality and relationships
- Teach pupils the correct vocabulary to describe themselves and their bodies
- Support the academy ethos of nurturing a caring community

3. Statutory Requirements & Legislation

The Greenwood Academies Trust follows the Department for Education statutory guidance that was statutory from September 2020. The guidance states which academies need to deliver relationships education, sex education and health education and what the RSE policy should include:

		The statutory requirement to provide Health Education does not apply to independent schools – PSHE is already compulsory as independent schools must meet the Independent School Standards as set out in the Education (Independent School Standards) Regulations 2014. Independent schools, however, may find the principles in the guidance on Health Education helpful in planning an age-appropriate curriculum.
The statutory requirements do not apply to sixth form colleges, 16-19 academies or Further Education (FE) colleges ⁷ , although we would encourage them to support students by offering these subjects. These settings may find the principles helpful, especially in supporting pupils in the transition to FE.

- As an academy we must provide relationships education to all pupils as per section 34 of the Children and Social work act 2017.

Within the Greenwood Academies Trust we assure that academies teach RSE as set out in this policy.

4. Definition

RSE teaches children and young people how to be safe and healthy. It teaches them how to manage their academic, personal and social lives in a positive way. RSE involves a combination of sharing information, exploring issues and values. RSE is not about the promotion of sexual activity or lifestyles.

Relationships Education: the focus is on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults. These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers). **See Appendices 1-3 for content mapping from Jigsaw scheme.**

Health Education: the focus is on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental wellbeing is a normal part of daily life, in the same way as physical health. **See Appendices 1-3 for content mapping from Jigsaw scheme.**

Sex Education: the focus is on teaching children the facts about puberty (preparing boys and girls for the changes that adolescence brings) and reproduction (how a baby is conceived and born). Parents have the right to request that their child be withdrawn from non-statutory sex education taught as part of RSE.

5. Equality, Diversity and Inclusion

Skegness Junior Academy is committed to providing Relationships and Sex Education (RSE) that is inclusive, age-appropriate and accessible to all pupils.

In accordance with the Equality Act 2010, teaching will be delivered in a way that does not discriminate against pupils on the basis of any protected characteristic, including age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, or sexual orientation.

The academy recognises that pupils come from a variety of family backgrounds and will ensure that teaching reflects the diversity of modern Britain. Learning will be delivered sensitively and respectfully, promoting understanding, tolerance and respect for others whilst recognising that families may have different beliefs and values.

All pupils will be encouraged to develop positive attitudes towards themselves and others, recognise and challenge prejudice, and understand the importance of respectful relationships. Teaching materials and resources will be carefully selected to ensure they are inclusive, accurate and appropriate to the age and maturity of pupils.

Reasonable adaptations will be made, where appropriate, to ensure that pupils with special educational needs and disabilities can access the curriculum and achieve the intended learning outcomes.

6. Curriculum Design

The curriculum for RSE is set out by each academy in line with this policy. Parents will be kept informed as per DfE expectations. Parents can view year-group curriculum overviews on the academy website and will be notified prior to the teaching of puberty and sex education units.

The curriculum at each of our academies will take into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online inappropriately.

The RSE programme is an integral part of whole school PSHE provision and will cover: Health and Well Being, Relationships and Living in the Wider World. It:

- is inclusive of equality and diversity and academies will demonstrate this by ensuring the curriculum enables all pupils to engage with it providing pupils with knowledge and awareness from a broad spectrum of society as a whole.
- will meet the needs, or be adapted for, those children with protected characteristics through teaching which respects and acknowledges all pupils.
- supports the demographic of the locality with staff and leaders being acutely aware of common issues and needs of our pupils.
- fosters gender equality and LGBT + equality by respecting the views and feelings of all and promoting an understanding of equality through openness and respect.
- will be planned and delivered through both direct teaching time each week and also across the curriculum with the core values being modelled

and embedded through daily routines. The curriculum acknowledges the range of ages and takes into account content when considering the age of the pupils it will be shared with.

- will be taught through a range of teaching methods and interactive activities.
- Will ensure that learning about relationships and sex education will link to/complement learning in science and SMSC.
- Will support pupils to understand personal safety and age-appropriate risk management, including how to recognise hazards and seek help in a range of everyday situations.

7. Bereavement, Change and Loss

The academy recognises that children may experience significant life events, including bereavement, family separation, relocation, illness, friendship changes and other forms of loss.

Through health and wellbeing education, pupils will be supported to understand that change and loss are a normal part of life and that individuals may experience and express emotions in different ways. Pupils will be taught strategies for managing feelings associated with change, loss and grief and will learn how and where to access support when needed.

Teaching will be delivered sensitively and with consideration for the individual circumstances of pupils and families. Staff will work closely with parents, carers and relevant professionals where additional support may be required.

8. Online Safety and Digital Relationships

The academy recognises that children's lives increasingly involve online communication and digital technologies. Online safety is therefore embedded throughout the RSE and wider curriculum.

Pupils will be taught how to build positive and respectful relationships both online and offline. They will learn about personal privacy, appropriate online behaviour, digital footprints, cyberbullying, online friendships, sharing images and information, and the importance of seeking support when something online makes them feel worried, uncomfortable or unsafe. Pupils will also learn about online scams, age restrictions, privacy settings, location sharing and other emerging online risks appropriate to their age and stage of development.

Teaching will also help pupils develop critical thinking skills so that they can recognise misinformation, scams, inappropriate content and attempts to manipulate or exploit them online. Pupils will be taught how to report concerns and how to access trusted sources of support.

The academy will work in partnership with parents and carers to promote safe and responsible use of technology and will ensure that online safety messages are reinforced through the wider curriculum and safeguarding procedures.

9. Delivery of RSE

RSE is taught at Skegness Junior Academy, within the personal, social, health and economic (PSHE) education curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE) and that of SMSC.

Primary schools are not required to teach sex education beyond the National Curriculum for Science. Where additional sex education is provided, parents have the right to request that their child be withdrawn from those non-statutory elements – see the table on page 4 for the DfE requirements.

Teaching will be adapted to meet the needs of pupils with SEND. Staff will ensure that pupils receive age-appropriate content at a level that enables them to understand relationships, personal safety, consent, privacy and healthy lifestyles.

Pupils will be taught the correct scientific names for body parts appropriate to their age and stage of development.

10. Managing Sensitive Questions

The academy recognises that pupils may ask questions during RSE lessons that are sensitive, unexpected or beyond the intended curriculum content.

Teachers will answer questions honestly, factually and in an age-appropriate manner whilst taking account of the maturity and understanding of the pupils present. Staff will use professional judgement when determining whether a question should be answered within the lesson, addressed individually at a later time, or referred to parents/carers where appropriate.

If a question raises a safeguarding concern, suggests that a pupil may be at risk of harm, or results in a disclosure, staff will follow the academy's safeguarding procedures and report concerns to the Designated Safeguarding Lead (DSL).

Ground rules will be established within lessons to create a safe environment where pupils feel confident to ask questions and express views respectfully. Pupils will be reminded that personal experiences and information shared within lessons may not remain confidential where safeguarding concerns arise.

Teachers will not encourage pupils to share personal or family information and will redirect discussion where necessary to maintain appropriate boundaries and safeguard pupils' wellbeing.

11. Roles and Responsibilities

The Trust

The Trust has a set of activities that will monitor the quality and effectiveness of the RSE policy and curriculum in each academy. The Curriculum Assurance Board will be key to the monitoring of this policy and will develop additional support or guidance to academies if required.

At Skegness Junior Academy, external visitors may supplement but never replace teaching by academy staff. All resources and content delivered by visitors

will be reviewed in advance by academy leaders.

The Academy

The Executive Principal is responsible for ensuring that RSE is taught consistently across the academy, and for managing requests to withdraw pupils from non- statutory/non-science components of Sex Education. The Executive Principal is responsible for ensuring policy and practice are adhered to and that all information is made accessible to all parents and carers.

- The nominated person for PSHE is responsible for development of the curriculum and monitoring of the curriculum across the academy.
- It will be taught by teachers in each year group.
- Teachers will receive RSE training as appropriate.

The Executive Principal should also ensure that there has been consultation with the academy community and parents/carers on the policy and curriculum for RSE in line with the guidance from the DfE. The academy should ensure that the policy is also published on the website. **Appendix 5** provides a template process for this.

Developing a policy

13. All schools must have in place a written policy for Relationships Education and RSE. Schools must consult parents in developing and reviewing their policy. Schools should ensure that the policy meets the needs of pupils and parents and reflects the community they serve.

What is required?

15. All schools must have an up-to-date policy, which is made available to parents and others. Schools must provide a copy of the policy free of charge to anyone who asks for one and should publish the policy on the school website⁸.

Staff

Staff are responsible for:

- Delivering RSE in a sensitive way
- Modelling positive attitudes to RSE
- Monitoring progress
- Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the non-statutory/non-science components of Sex Education

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Executive Principal. All class teachers are responsible for teaching RSE.

Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

12. Safeguarding

Academies must consider how safeguarding and confidentiality protocols support safe and effective RSE practice.

- Teachers should be aware of the academy confidentiality policy.
- Teachers are aware that effective RSE, which brings an understanding of what is and what is not appropriate in a relationship, can lead to a disclosure of a child protection issue.
- Teachers will consult with the designated safeguarding lead who will follow academy policy for safeguarding.
- Visitors/external agencies which support the delivery of RSE will be required to adhere to academy safeguarding policies, confidentiality and the RSE policy.

13. Parents' right to withdraw

Parents do not have the right to withdraw their children from relationships education. Parents have the right to withdraw their children from the non-statutory/non-science components of sex education within RSE. See Appendix 4 for DfE guidance on this issue.

We conclude that sex education refers to Human Reproduction, and therefore inform parents of their right to request their child be withdrawn from the PSHE lessons that explicitly teach this i.e. the Jigsaw Changing Me Puzzle (unit)

Year 4, Lesson 2 (Having a baby)

Year 5, Lesson 4 (Conception)

Year 6, Lesson 3 (Conception, birth)

Each academy is encouraged to be clear in their curriculum mapping which aspects of learning are 'Relationships Education', 'Sex Education' and 'Health Education' to support parents in decisions over withdrawal.

Requests for withdrawal should be put in writing (optional form can be found at **Appendix 3**) and addressed to the Executive Principal. The trust would expect the Executive Principal to honour appropriate requests for withdrawal and meet with parents to discuss these in line with the DfE guidance as summarised in **Appendix 5**. Alternative work will be given to pupils who are withdrawn from sex education.

14. Training

Staff are to be trained on the delivery of RSE.

The Executive Principal may also invite visitors from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE.

15. Monitoring Arrangements

The delivery of RSE is monitored in academies by senior leaders through activities such as planning scrutinies, lesson visits, children and staff surveys. Pupils' development in RSE is monitored by class teachers as part of internal assessment processes.

The implementation of this policy is monitored by the Trust through:

- ✓ Assurance activities to ensure statutory arrangements are in place in each academy
- ✓ Assurance activities to ensure the academy policies are being implemented and the RSE curriculum in each academy is of sufficient quality
- ✓ This policy will be reviewed regularly and the Curriculum assurance Board will lead the development of any amendments to the policy.

16. Assessment

There are many reasons why it is important that learning in PSHE, including RSE, is assessed, including:

- Pupils need opportunities to reflect on their learning and its implications for their lives.
- Teachers need to know that learning has taken place, be able to demonstrate progress and identify future learning needs.
- Assessment increases pupils' motivation and improves learning, as their raised awareness of their progress illustrates the value of this learning.
- Assessment allows the leadership team, parents, governors and school inspectors to see PSHE education's impact on pupils and whole school outcomes, such as Ofsted judgements on personal development, safeguarding, spiritual, moral, social and cultural (SMSC) development and the promotion of fundamental British values.
- Without assessment, all a school can do is describe its PSHE provision, not show its impact.
- The DfE also states in the statutory guidance for Relationships, Sex and Health education that "schools should have the same high expectations

of the quality of pupils' work in these subjects as for other curriculum areas" — therefore assessment for and of learning should be central to any PSHE education provision.

At the Greenwood Academies Trust:

- Pupils will be provided with time to discuss and share their thoughts and feelings appropriately
- Adults will be expected to respond to pupil needs through follow up work that could be whole class, small group or 1:1.
- Pupils will have opportunities to review and reflect on their learning through activities including reflection time, discussion, written work and artwork.
- Pupil voice and assessment will be used to adapt and amend planned learning activities
- Parents will be informed of pupil understanding in the usual ways including via parent consultations and written reports.

Children develop at their own rates, and in their own ways. The development statements and their order should not be taken as necessary steps for individual children. They should not be used as checklists. The age/stage bands overlap because these are not fixed age boundaries but suggest a typical range of development.

The development of positive relationships is a key strand that runs through every area of learning in the early years. There is a specific learning intention about families.

This contributes to the early learning goal: *showing sensitivity to others needs and feelings.*

- To recognise that all families are different

Learning Outcomes

- Identify different members of the family
- Understand how members of a family can help each other

Appendix 2: Primary Expectations



Relationships Education in Primary schools (Appendix 2) – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults. The references R3/H5 etc can be cross-referenced on the Jigsaw mapping documents and Puzzle Maps to show which lessons throughout Jigsaw contribute to which statutory outcomes. All statutory outcomes are covered in the Jigsaw 3-11 Programme.

The guidance states that, by the end of primary school:

Physical health and mental well-being education in Primary schools – DfE Guidance 2019

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:

Right to be excused from sex education (commonly referred to as the right to withdraw)

45. Parents have the right to request that their child be withdrawn from some or all of sex education delivered as part of statutory RSE. Before granting any such request it would be good practice for the head teacher to discuss the request with parents and, as appropriate, with the child to ensure that their wishes are understood and to clarify the nature and purpose of the curriculum. Schools will want to document this process to ensure a record is kept.

46. Good practice is also likely to include the head teacher discussing with parents the benefits of receiving this important education and any detrimental effects that withdrawal might have on the child. This could include any social and emotional effects of being excluded, as well as the likelihood of the child hearing their peers' version of what was said in the classes, rather than what was directly said by the teacher (although the school should respect the parents' request to withdraw the child, up to and until three terms before the child turns 16. After that point, if the child wishes to receive sex education rather than be withdrawn, the school should make arrangements to provide the child with sex education during one of those terms.

48. This process is the same for pupils with SEND. However there may be exceptional circumstances where the head teacher may want to take a pupil's specific needs arising from their SEND into account when making this decision. The approach outlined above should be reflected in the school's policy on RSE.

49. Head teachers will automatically grant a request to withdraw a pupil from any sex education delivered in primary schools, other than as part of the science curriculum.

50. If a pupil is excused from sex education, it is the school's responsibility to ensure that the pupil receives appropriate, purposeful education during the period of withdrawal. There is no right to withdraw from Relationships Education or Health Education.
